Sedate mare, put in local block, and drain seroma; cut 1 inch diameter hole for drainage. Recommend clean the area daily, allow exercise as that will keep it open and draining. prognosis is good for healing with minimal to no scarring. She is moving much better than when it happens; no significant lameness at this time.
6/4/2016	I	D	Mare was fund with a large swelling over her right stifle, and difficulty walking. On examination, she has traumatized her stifle and has a large seroma; there is extensive abrasions proximal to the swelling. the lateral aspect of the thigh is very painful to touch; she resists any manipulation. Owner has not been able to find where she injured herself; but it appears she got her leg over a blunt object and fought to get free. Unable to tell the extend of the injury at this time due to the sensitivity and swelling, but she is able to bear full weight on the leg, she resists bringing it forward. Treat with anti inflammatory medication at this time, give Banamine IV, and dispense Bute to follow up tomorrow; give 1 gm twice daily orally. Recommend keep an ointment on the
